No other mode of application will be accepted. Before applying candidates are advised to ensure that they fulfil the stipulated eligibility criteria otherwise their application will be summarily rejected.

5. PAY AND ALLOWANCES

- a) The Bank shall pay a lump sum amount of ₹30,000/- per month inclusive of statutory deductions & contributions as applicable to the GDSs engaged to IPPB as Executives.
- b) Tax deductions will be done as per IT Act as amended from time to time.
- c) Annual increment of lump-sum pay and incentives based on performance in business acquisition/sales activities as decided by the Competent Authority.
- d) Further, it is clarified that no other pay/allowances/Bonus etc. shall be paid except those mentioned in above.

6. TENURE OF ENGAGEMENT

- a) The tenure of engagement shall be for one (1) year which may be reviewed for extension on year-to-year basis for another period of 02 years, subject to satisfactory performance if required, as per the Bank's business requirements and in the exigencies of public services and the candidates shall not be eligible for regular absorption in IPPB.
- b) Business performance shall be reviewed every six months. In case performance is found dis-satisfactory over two consecutive reviews, the engaged GDS may be repatriated after serving one- month notice.
- c) There shall be a mandatory 'cooling off' period of two years after every period of temporary engagement of GDS in IPPB as Executive. Therefore, GDS who were engaged with IPPB as Territory Officer/Business Associate/Executive in the past, shall be eligible to apply under this recruitment exercise only, if they are not in the mandatory 'cooling off' period.

7. SELECTION PROCEDURE

- a) Selection will be made on the basis of percentage of marks obtained in the graduation. However, the Bank reserves the right to conduct Online Test.
- b) In case of equal graduation percentage obtained by two candidates in the merit list then the candidate having seniority in service at DoP shall be selected. In case the seniority in service is also same, the candidate will be selected bases the date of birth.
- c) Candidate shall fill exact percentage of marks obtained in the Graduation up to two places of decimal as mentioned in the degree certificate. If any deviation is found in the application form with respect to the percentage of marks mentioned in the degree certificate, such applications will be summarily rejected. In cases, where CGPA is awarded, candidate shall have valid document issued by the University/Institute for conversion of CGPA to percentage marks.
- d) The candidates will be called for Document Verification basis the circle wise merit list.
- e) During Document Verification, candidates will have to furnish the following:
 - i. No Objection Certificate (NOC) from his controlling officer
 - ii. Statement giving details of Major/Minor penalties, imposed upon the Employee, if any during the last five (5) years.
 - iii. Vigilance Clearance Certificate from the Divisional Head.
 - iv. The engagement with IPPB shall commence only after completion of mandatory formalities pertaining to their relieving process as stipulated by their parent organization.
- f) Merely satisfying the eligibility norms do not entitle a candidate to be in the select list.
- g) Results of the candidates who have qualified for various stages of the recruitment process and the list of candidates finally selected will be published on the website.

8. APPLICATION FEE

Application Fee of ₹ 750/- (Non-Refundable) is payable. Candidates should ensure their eligibility before paying the fees/applying online. Application once made will not be allowed to be withdrawn and fee once paid will NOT be refunded under any circumstances nor can it be held in reserve for any other future selection process.

9. LEAVES:

- a) GDS as Executive at IPPB shall be guided by the existing Leave Rules provided in the GDS Conduct & Engagement Rules, 2020. However, due payment of leave period shall be made by IPPB.
- b) GDS on engagement to IPPB will be treated on duty for his/her entire period of ad hoc engagement in IPPB. The ad hoc engagement with IPPB will be counted as service rendered in GDS post for the purpose of seniority, annual increase and determining discharge benefits in the GDS post.

10. CODE OF CONDUCT:

- i. A GDS engaged shall continue to be governed by the GDS (Conduct and Engagement Rules) 2020. In case a GDS engages in misconduct during his/her tenure at IPPB, IPPB will raise the issue with concerned authority at DoP and suitable action, including repatriation, may be undertaken as per applicable rules.
- ii. In cases where repatriation is done on account of indiscipline, misconduct, insubordination, unruly /violent behavior, IPPB shall transfer all records and evidence of the erring GDS (if any) to the parent organization.
- iii. This engagement shall be for a fixed tenure, as stipulated in Para 6 above, and the candidates shall not be eligible for regular absorption in IPPB.
- iv. IPPB shall reimburse the proportionate discharge benefits including DoP subscription to NPS etc. to DoP for the period for which the GDS serves at IPPB. This reimbursement shall be made every year on the last date of financial year i.e. 31st March.

11. OTHER TERMS & CONDITIONS

Any other terms and conditions pertaining to engagement of GDS shall be governed by the guidelines issued by the Bank in this regard from time to time.

12. ACTION AGAINST CANDIDATES FOUND GUILTY OF MISCONDUCT:

Candidates are advised in their own interest that they should not furnish any particulars/details/information or make statements that are false, incorrect, tampered, fabricated and should not conceal or suppress any material information while filling up the application form and submitting the attested copies of testimonials. In case it is detected at any time that the candidate has indulged in any of the above-mentioned activities, he/she will not only be disqualified but will be liable to be dismissed from the services of IPPB at any time, even after being selected and after joining IPPB's service. If a candidate is (or has been) found guilty of:

- i. Using unfair means during the selection process, or
- ii. Impersonating or procuring impersonation by any person, or
- iii. Resorting to any irregular or improper means in connection with his/her candidature, including resorting to canvassing for his candidature, or obtaining support for his/her candidature, by any means, such candidate may, in addition to rendering himself/herself liable to criminal prosecution, shall also be liable:
 - (a) To be disqualified from the selection process for which he / she is a candidate;
 - (b) To be debarred, either permanently or for a specified period, from any examination or recruitment conducted by IPPB.

13. GENERAL INFORMATION

- a) Incomplete application, in any respect shall be rejected and no further correspondence shall be entertained. In addition, no other means/mode of submission of application shall be accepted under any circumstances.
- b) If any discrepancies are found between the data filled by the candidate online and the original testimonies, his candidature is liable to be rejected.

- c) If any information provided by the candidate is found to be false or incorrect or not in conformity with the eligibility criteria, then his/ her candidature is liable to be rejected at any stage of the recruitment process or after recruitment or joining.
